To offset this, Irvine Ranch Co. officials have established a facility for a Club station in their high-rise office building and are financing a station for use by ham residents. 
4. Ed Thornley read a letter received from the Headmaster of Chadwick School, on whose site our last Field Day was held. While indicating that the Club left their property "in fine condition", it stated that similar use in following years must be predicated upon our obtaining at least \$100,000 property damage and \$300,000 bodily injury insurance. Additionally, they will also require a certificate of insurance providing evidence of Workmen's Compensation coverage. After discussion, it was agreed to investigate costs that might be involved in meeting this requirement. Ed will review with the TRW insurance department.
5. President Ed requested Treasurer Bill to avoid future use of "not to exceed"-type checks. Club disbursements should be executed for exact amounts.

COMMUNICATIONS COURSE TO BE OFFERED

A beginning through advanced course in International Morse Code, will be offered by the Inglewood Adult Education Division, Thursday evenings, 7:00 to 10:00 p.m., Building M, Room 202, Inglewood High School, starting September 17, 1970. Registration will be held in the classroom the first evening - enrollment fee for the course is \$5.00.

Knowledge of the code can provide the boating enthusiast with an additional communication device during emergencies, and by understanding Navigation Beam Station identification codes. Older scouts can benefit through obtaining their Radio and Communication Merit Badges. Some commercial FCC examinations and radio amateur examinations require knowledge of the code.

The course is designed for progression through speed levels on an individual basis. A unique method provides a rapid understanding of all characters. Emphasis on sending and receiving the code.
