## EMERGENCY COMMUNICATIONS

This month the RACES (Radio Amateur Civil Emergency Service) folks participated in a South Bay area disaster drill. The drill, which featured a simulated earthquake, was pretty successful, and it provided some reminders for all of us.

Emergency communications require a combination of traffic handling and equipment improvisation skills. It is also necessary to have a place to communicate with, and to know what you are going to say. This translates into a need for organization and training.

An individual with just a radio, emergency powered or not, is not much use when the ground begins to shake, even if he or she is a skilled amateur. And a real disaster is not a great place for on the job training. If you are not prepared beforehand, you will be more of a liability than an asset.

IS A HAM RADIO WATERGATE in the making? A story from the SCDXC Bull, relayed from HR Reports and the Indianapolis Star, concerns the sale of General Class amateur radio licenses by a group of individuals which included "a government employee in Pennsylvania" with access to the Commission's licensing computer, who provided the computer with instructions to issue the purchased license. The FBI is reported to have the matter under investigation.

THE FCC HAS PROVIDED 17 new channels to the 23 in the 27 MHz citizen's band. Use of the new channels will start January 1, 1977.

MEXICO NO LONGER issues temporary permits to allow CB operation by Americans visiting Mexico. Flagrant abuses apparently caused Mexico to drop the former cooperative policy. It is reported that CB-equipped vehicles are not being allowed to enter Mexico.

WT PREFIXED CALLS are being issued to Novices and other amateurs until their permanent call signs are issued.

THE ARRL HAS WIRED THE WHITE HOUSE to the effect that the amateur community is concerned about reports that the WH Office of Telecommunications Policy might recommend withdrawal of frequencies in active amateur use in order to create a new General Radio Service apparently desired by certain commercial interests.

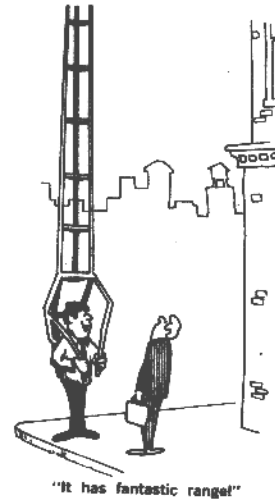
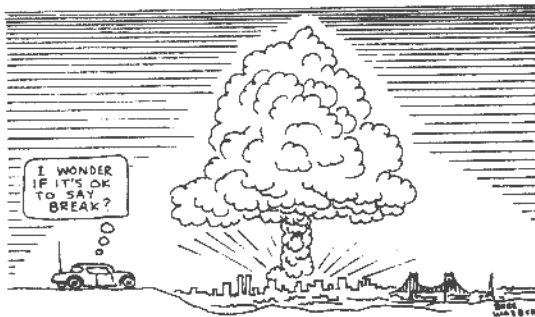

FROM THE TRW/ARC ACTIVITY MANAGER

You may have noticed in August CROSSTALK the expense item for crystals for the club IC-230. Stan Johnson, W6EKK, modified it to permit split-reverse operation, and it is now available for use by club members on a loan basis. The rig comes with its attached AC power supply; contact pres Frank Cartier for info on the loan schedule and arrangements. (X51188)

The W6TRW HF tower repair job has not yet been completed. A new thrust bearing plate is being obtained, and a climber will be needed to install it when subassembly with the bearing is completed.

A work party is scheduled for Saturday, 2 October at 0800 at W6TRW. Tasks will include clean-up of the operating areas and detailed planning for the tower rotator installation.

Not much real progress has been made on a 2 meter repeater for the club. Obstacles include the lack of a frequency pair for such a repeater (W6FQ reports that SCRA doubts availability), and the general lack of useful enthusiasm (translation: \$\$) on the part of potential users. Also, it seems that when the 37/97 Palos Verdes repeater temporarily came to life, a good many .51 folks abandoned the club's simplex frequency. It may be significant, too, that the .075/.675 repeater is not receiving much use. Adding up all of the above, the rationale for another 2 meter repeater may just not be there... oh well.

TRW/ARC Executive Committee Meeting, September 1976

The following represent memoirs rather than minutes, being the recollections and collected writings of Dave Carson, our treasurer, acting in the absence of our customary scribe, Ed Thornley.

Meeting called to order at 6 PM by President Cartier. Present were Cartier, Halligan, Carson, Dews, Weisz; QTH was Dews residence.

1. Dews moved, Halligan seconded that club purchase 7500 Pioneer 11 QSL blanks for \$145.73 from H. S. Crocker Company. Order to be placed by Thornley. This is to be an interim purchase to cover members' needs until a new style card can be approved and purchased. The motion passed on a 3 to 1 vote.

2. The above motion also includes a provision increasing QSL card prices by 33 per cent. Order forms to appear in September and October CROSSTALK.

3. The November Dinner Meeting will be on November 6, with arrangements to be made by Thornley (who was not at meeting!). Cost to the club will be \$7.50/person. The club will pick up the tab for the speaker and a guest, and for Mr. and Mrs. Carl Rothrock. Price of tickets will thus be \$9.00 each to permit club to break even. Special price of \$17.76 will be offered to pairs of consenting adults. Those registering (and paying) before 15 October will be eligible for a second and separate door prize drawing for a \$40 prize. Regular raffle will also be held, with tickets to be sold at the door for prizes to be worth \$50.

4. September meeting door prizes to be \$25 worth of books from the exchange of previously purchased thrust bearing, and also a 6 meter AM transceiver with mike. October prizes to be only ARRL memberships since the dinner meeting follows so closely.

4. The budget projections published in July CROSSTALK, showing the TRW/ARC well down the road to financial disaster, were discussed with a view toward decreasing expenditures or increasing income. One area discussed as a possible cost reduction was the club magazine subscriptions, which run about \$50/year. Dews is to check usage of available magazines on checkout sheets maintained by Librarian Jack Koho. If benefits are not substantial, subscriptions will be discontinued.
