I read some on this type of interferance but until you hear it you won't believe it. Hope 'WARC' can help save Ham radio?

THE LOG OF THE DX'ER - continued from last month

Background: Jerry Tell, of R3-2120, sailed his 30 foot Personal yacht, the DX'er to Bermuda. Storms were encountered on the way back, and about 60 miles off Montauk, out of gas and with a damaged main sail, the following events took place.

The boys were visibly exhausted and they laid down as we talked quietly about nothing really - how wonderful the hams were; what a superb job the pilot did on his drops. Within minutes the boys were sound asleep. Diana and I decided not to wake them until we spotted the Point Heron. I hung out some of our clothes and straightened up a bed. Now comes the wait, I thought, but not too long. About 1450 hours, Diana and I decided we should alternate watches for the cutter. 1630 hours came and no sign of the Point Heron. But, of course, we realized that it cannot be exact. 1730 - still no sign of the cutter, by this time, we began to wonder.

At 1800 we decide to wake the boys. They awoke more or less still dazed for they really needed the sleep. We decided that we should try to contact the cutter by the radio; perhaps the beacon wasn't working. Lt. Burns had given us our exact fix. We were 60 miles from Montauk - we had really drifted a long way. When we turned on the radio all we could hear was a siren sound. This confused us. Then Jerimiah said maybe it was the beacon that we had on board. He decided to see if we could pick up the same sound with the RDF, and sure enough we did.

By 1900 hours, we were a fairly dejected group. Night would be upon us soon and we couldn't put on any lights because they would run down the battery. Here we were in the middle of the Atlantic Ocean, unable to sail (by this time the sea was calm and the wind had died down) or motor, 60 miles from land. We knew that Jerimiah would never be able to make it back to work by Monday, and his vacation time was up. So we decided to play cards to pass the time and to restore our sense of humor, for we were all becoming a bit uneasy. We even decided to boil some water and we had a Cup-A-Soup with Chinese noodles.

By now it was 2000 hours and we began to seriously discuss our situation. We thought, perhaps, that since our situation was not a Mayday, the Coast Guard might not come until morning. The prospect was a bit depressing. Jerimiah finally said that he would try to sew the sail by hand and see if we could not somehow make it in. Although we knew that if the wind picked up again, his repair job certainly could not hold up, we decided to try anyway. We galvanized into action. This proved to be the wisest thing, for it was the idleness that was depressing us. I went up top with Jerimiah to hold the light as he

sewed. It was cold, but it felt good to be doing something again. We had decided we would not leave the spot without first getting a phone patch into the Coast Guard because we could envision their arriving and our not being there. This would precipitate an air-sea search of great magnitude and we certainly did not want that. We were really fooling ourselves, of course, but at least we had the feeling that we were doing something. There is nothing as frustrating as being helpless.

Then all of a sudden we spotted a light off our bow, unmistakably a boat. Then almost immediately, another light off our stern. "They're here!" we cried, but why two?

At 2130 hours the Coast Guard vessel Point Wells was along side and we were talking to the Captain of the "toy" radio. We told him that if he would give us some gas, we would finish repairing the sail and if we couldn't sail we could then motor. The Captain told us first of all they do not have any gas and that secondly, the sea was starting to build up again and he would prefer to tow us in. So we tied the line to our bow deat and then the Captain asked us what our hull speed was. Without that information, if he went too fast he could pull our deck off and we could break in two. By 2200 hours we were underway and very relieved to be so.
