

We had 30 people in attendance. 26 Clubs were represented.

We had two representatives from the F.C.C.: Miss Cathern Valdez and Grace Poier. They are part of the Out Reach Program. They are from the Long Beach Office which is Headed by Larry Guyse. They consented to set in and hear the discussion about the Plain Language Proposal to change the Amateur Radio Rules.

Public Relations: Hughes Amateur Radio Club handled communications for the Play Vista 10K Runs which was held at the end of March and the first of April in Culver City. They also handled communications for the St. John's Hospital 10K Run at the Marina Del Rey.

QSL Bureau: They received approx. 19,600 cards, 4,465 envelopes., 5700 envelopes and cards were mailed out. We had 50 packages sent by first class mail. 1650 notices including envelopes that were mailed out through National Traffic System and 250 post cards.

The Dannenmeyer Bill #HR2203, is still in committee. The Bill is in reference to Malicious interference, illegal Maritime Mobile call signs, and to allow the F.C.C. to use volunteer help.

Plain Language F.C.C. Rule Changes for Amateur Radio: Every Licensed Amateur Radio Operator should become intimately familiar with this proposal since we will have to live with the final results for many years to come. Docket 80-729 is a notice of proposed rulemaking (NPRM). NPRMs are issued by the FCC to give the public an opportunity to express their opinions on the proposed rule changes. The FCC measures our interest by the total number replies received, whether they are good, bad, or indifferent. A handful of replies indicates to the Commissioners that "they really don't care what we do". So we should all send in comments even if it is to say you think the idea is good.

The Federal Register of December 19, 1980, contains 51 pages devoted to PR Docket 80-729 "Revision of the Amateur Radio Service Rules into "Plain Language". Comments must be in FCC hands by June 19, 1981. (There is a good chance that ARRL will ask for and get an extension of time). The February 1981 QST, page 49, contains an article on this docket. You would do well to look this article over thoroughly, and obtain a copy of the complete docket from ARRL. 225 Main St., Newington, CT 06111. Enclose \$1.00 to help defray printing and postage.
