Beginning at the December 1987 Amateur Radio Club Swap Meet which will be held Saturday, 26 December, a major change in the operation of the Swap Meet will occur. reason for the change is to comply with the laws of the State of California and the TRW Systems Employee Association (SEA) rules and requirements. In order to comply with these requirements, we will have to charge a in order to cover seller's fee administrative and operating expenses. return, however, the selling participants will receive a number of convenient features. Among these features are specific space assignments that can be purchased in This will allow sellers to know advance. exactly where they will be located each month and can avoid waiting in line during the night before the Swap Meet and the mad rush to find that "perfect" space when the Swap Meet opens at 0700. This will also help ensure the continuation of the Swap Meet, since the local residents and TRW are not very pleased about the overnight campers in front of homes and/or TRW property.

The detailed rules, regulations and fees are provided on a separate page in this issue of the Crosstalk.

With the exception of space reservations and fees, the basic approach to the Swap Meet is the same. It is primarily for the benefit of the Amateur Radio community, and as you will see from the sellers fee schedule, the preference is given to Amateur Radio operators and TRW/ARC members. Only amateur equipment and related electronic radio allowed. No is equipment merchandise, electronic toys, or food of any kind. Related electronic equipment includes computer hardware and software, electronic parts, test equipment, tools and Amateur Radio accessories. We have always taken a broad view of "Amateur Radio related," but the judgment of the Swap Meet crew will always be final.

The TRW Amateur Radio Club Swap Meet has become a Southern California Amateur Radio institution and an event many people look forward to each month. It has grown to its current full capacity because it provides Radio operators with Amateur opportunity to obtain items for their stations that otherwise might be difficult or impossible to find at sometimes bargain prices. Our intention is to provide a quality event and we hope everyone who has been involved in the past will continue to support it and the new requirements we must abide by.

At the next two Swap Meets, on Saturday October 31 and Saturday November 28, we will have a booth set up near the main entrance for advance space reservations and additional information. In the meantime, and between Swap Meets, information and reservations can be obtained by mail on a first come, first serve basis. The address for Swap Meet information/reservations ONLY is:

Enclose with each space reservation request the appropriate fee for your category along with a copy of your TRW/ARC Club card (if applicable) and your Amateur Radio license. Also required is your Driver's License number, telephone number (for confirmation) and your address.

The Swap Meet operating hours will remain the same -- 0700 to 1130.

There are big changes coming about in the operation of the TRW/ARC Swap Meet and these will require a bigger work force than we have needed in the past. It also means that we will need a work force that has some experience and month to month continuity that has been lacking in the past. ideas have been put forth and they all up to we need more help from our membership, but we will now be able to reward the commitment you will be required to make. Due to the fact that we are now charging sellers for the privilege of operating at the Swap Meet, we will be able to afford a modest gift for those who decide to help for a few months with the Swap Meet. The exact nature of the gift has not been determined due to the fact that it will take us a few to sort out our income expenses and determine the cash flow we will have. However, if you are interested, contact the Swap Meet Manager, Frank Cartier, WA6RAY, and let him know that you are ready to help out in any way you can. Frank can fill you in on the details when he talks to you. We are looking for persons that will handle mail reservations, cash at the Swap Meet, database updating, handling of the State of California forms for the sellers and two crews of Swap Meet workers one early and one late morning. TRW AMATEUR RADIO CLUB SHAP MEET RULES AND REGULATIONS

- Sellers will be assigned specific spaces - 371 "single" spaces - 26 "end" spaces.
- Spaces can be purchased 6 months in advance.
- 3) Sellers who buy 6 months in advance will be allowed right of first refusal after that time.
- 4) Amateur radio and radio/computer electronics related items only -- no general merchandise, toys and no food items.
- 5) Sellers lot opens at 0700. No one allowed on TRW property until 0630.
- 6) Sellers lot closes at 1130.
- 7) Sellers will be required to purchase a ticket for each specifically assigned space(s) and hold their tickets for space verification by the Swap Meet crew.
- 8) Walk-in buyers are not charged an entry fee.
- 9) No more than 3 spaces per seller.
- 10) Spaces not occupied by 0830 will be subject to resale for that day.
- Sellers must complete and sign:a) State of California Information Report.
 - b) TRW Release Form.
- 12) No refunds due to weather conditions or any other reason.
- 13) Waiting list for "high demand" spaces will be maintained.
- 14) Drivers license for identification is mandatory.
- 15) Checks will be accepted only for advance reservations. Cash only on date of the Swap Meet at the entrance.
- 16) Certain vehicles will require a minimum of 2 spaces: examples are:
 - a) Cars/trucks with trailers
 - b) Motor Homes
 - c) Large Vans
 - d) Panel Trucks
 - e) Specialized vehicles

Decisions by the Swap Meet crew on the number of spaces required is final.

- 17) One complete row (not including "end" spaces) will be reserved for Amateur Radio operators only (copy of license required).
- 18) One complete row (not including "end" spaces) will not be sold in advance.
- 19) All transactions on a first come, first serve basis (except as noted above).

- 23) Anyone not complying with the letter and intent of these rules will not be allowed to participate.

President Chris Wachs opened the meeting and noted that much had to be discussed this evening and cautioned all not to get into verbal free-for-alls, but wait your turn to speak. LAACARC Delegate Steve Ng requested that copies of the new Swap Meet rules that were to be worked out this evening get to him before the November 3rd meeting of the LAACARC so that he could take them with him

and disburse them to the other clubs. Swap Meet Manager Frank Cartier went over the proposed changes to the Swap Meet rules asking all to wait until he had finished before commenting. Frank gave out several handouts of his proposed rules while he went over them. Following his presentation questions and statements were made by those in attendance, some of which incorporated into the draft of new rules. When all of the discussion had ended Frank moved that the rules be adopted as amended. The motion was seconded by Jim Wike. The motion passed unanimously. Chris moved that the Club use P.O. Box 3525, Manhattan Beach 90266 as the mailing address for the Swap Meet, that the Club obtain a phone line and purchase a remote control phone answering machine to contain a Swap Meet information tape recording. The motion was seconded by O'Neal. The motion unanimously. Vice President Steve O'Neal moved that \$150 be appropriated for the purchase of a phone answering machine. motion was seconded by Chris Wachs and a short discussion followed. The motion was passed unanimously. Mike Aust requested that the Club purchase four lightning arrestors at a cost of \$45.50 each for protecting the repeater and ham shack equipment. The motion was seconded by Steve O'Neal and passed unanimously. Emergency Communications Team Coordinator Rich Sauer made a motion to purchase six Icom Battery Inserts at \$23 each. The motion seconded by Frank Cartier and passed with one vote not in favor. Chris Wachs and Treasurer DAve Stockwell took responsibility for working on the Club Annual Banquet so that information would be ready for the next issue of the Crosstalk. Dave Stockwell passed out a "strawman" budget for the next year, trying to take into account the income

The Safety Net

(A Safety Alert from Industry)

Two recent incidents have uncovered a previously unknown phenomenon of serious gravity:

- 1. At Duquense Electric a worker threw an electrical switch into a closed position which produced a short lived spark.
- 2. An employee at UPS flipped open the colored lens of his welding shield to better position the welding rod. He inadvertently struck the metal to be welded, producing an arc.

BOTH MEN WERE WEARING CONTACT LENSES.

On returning home from work they removed the contacts and the Cornea of the eye was removed along with the lens. The result was TOTAL BLINDNESS.

The electric arc generates microwaves that instantly dry up the fluid between the eye and the lens, causing the cornea to be bonded to the lens. The trauma is painless and the individual never knows an injury has occurred until they remove the contacts.

At the time the incident was reported, the phenomenon was unknown to the Federal and State Safety and Health agencies and they did not have any safety regulations on the matter. They were pursuing the investigation zealously.

In the meantime it is suggested that no contact lenses be worn by anyone who is potentially subject to an electrical sparking situation.
